## Liberty Mutual Insurance Cheats Policyholders and Accident Victims

On December 16, 2014, at a Pizza Hut in Detroit, Michigan, customer Cheryl Harris' left index fingertip was chopped off as she reached in for her pan pizza from a pizza dispenser. The injury, pain and ongoing trauma she suffers

are clearly due to the negligence of Pizza Hut and only exacerbated by the shoddy treatment she is receiving from Yum! Brands/Pizza Hut and its insurer Liberty Mutual. Liberty Mutual claimed she suffered a pinched finger and offered her

\$35,000 and later \$45,000 to cover the negligence and all her medical costs!

Their offer was followed with a statement from a Liberty Mutual representative saying, "This is what we offer those in the Detroit area." The public must ask, "Is Liberty Mutual's Detroit policy due to the fact that 83% of those residing in the City are African American?"
